The Regional Joint Directors of Collegiate Education and Principals of Government Degree Colleges in the State are informed that in the reference read above, the Government has directed that it is mandatory to enter the details of all Public Information Officer (PIO) & and First Appellate Authority (FAA) in the State in the login of DDOs at data input screen to APCFSS application.

(On entry, the name of the employee, the address of the office, mobile number & email id of employee will be displayed and to be confirmed by the HoO)

3.3.1 Number of FAAs in the office/institution: Select 0 to 10.

3.3.2 CFMS Id of the First Appellate Authority/s (FAA/s): Numeric entry (On entry, the name of the employee, the address of the office, mobile number & email id of employee will be displayed and to be confirmed by the Head of the office/Institution.

4. (a) In case of an office having multiple PIOs/multiple FFAs, the details of all the PIOs & FAAs has to be compulsorily entered.


(b) The details of FAAs have to be entered if there is a FAA in the same office/institution. If there is no FAA in the same office, then 0 may be selected at 3.3.1.

All the RJDCes and Principals of Government Degree Colleges in the State are directed to complete the data entry on or before 5<sup>th</sup> August 2025 through the






